Brief report of the activity	<p>the Department of Commerce and Management Studies hosted a guest lecture on "Changes in Taxation in India" by esteemed Chartered Accountant P.V. Krishna. The event, attended by final-year undergraduate and postgraduate students, aimed to provide insights into recent tax reforms and their implications.</p> <p>CA P.V. Krishna elucidated key changes in India's taxation system, focusing on the Goods and Services Tax (GST) and its impact on economic growth. He highlighted the abolition of entry tax and Central Sales Tax, reducing logistical costs for manufacturers. Krishna also discussed the reduction in corporate tax rates to 22% for domestic companies (2019-20) and the removal of Dividend Distribution Tax, enhancing the equity market's attractiveness. He emphasized the Vivad se Vishwas scheme for resolving tax disputes, benefiting both government and taxpayers.</p> <p>The session was interactive, with students engaging in discussions on GST's role in economic efficiency. Krishna's practical insights enriched the students' understanding of taxation's evolving landscape, preparing them for careers in commerce and management.</p>







